

## **PROGRAM OVERVIEW**

The **Safe-Tech Working at Heights Refresher Program** meets or exceeds all requirements of the **new** Working at Height Refresher Guideline and is applicable for workers who were previously certified by a CPO approved training provider. *Participants must possess proof of prior training; either a* CPO-issued card or a certificate of training issued by the approved training provider. The Chief Prevention Office will not issue a record of refresher training to a learner who has not previously completed a CPO approved Working at Height program. Refresher training is mandatory every 3 years for a worker to maintain certification validity.

## COMPLIANCE

Program is in compliance with Ontario regulation 213/91 section 26 of the Construction regs and meets or exceeds all requirements of both the CPO Approved Working at Heights Refresher Program Standard and Training Provider Standard.

## **COURSE REQUIREMENTS**

Each learner *must have completed a Basic Occupational Health and Safety Awareness Training* course under Ontario Reg. 297/13 before attending a Working at Heights program (copy link below).
